




2) Supplier Login Screen


- Access the DEWA portal(https://www.dew.gov.ae) and select **Supplier** from the login options.
- Enter your **Username** and **Password** to sign in.




3) Navigating to Authority Letter

- After logging in, go to the Dashboard.
- Under Main Services, select Purchase Order.
- Locate your relevant Purchase Order from the list.









4) Request Application Screen for Regular Category Letter

- Click + New Request to initiate a new Authority Letter application.






5) Filling the Authority Letter Request


- Enter the following details in the application form:

- Click Submit.






6) Submission of Request












- Download the official Authority Letter PDF for your records and submission to customs.








12) View the Rejected Authority Request

 Once rejected, the Authority Letter cannot be viewed and downloaded from the Authority Letter section and rejection email will be sent to authorized email id for Supplier.






